Governor Signs Interim Fix for Provisional Hiring Needs and Local Advertising Bills to be Introduced

[Act 18](#) (HB 360), signed by the Governor on May 8, is an interim measure related to childcare background check delays caused by COVID-19. Act 18 suspends portions of Act 47 of 2019, which amended the Child Protective Services Law reducing the availability of provisional hiring waivers to only licensed child day cares, group day care homes or family childcare homes. Act 18 extends the waivers to all employers and allows provisional hiring through December 31, 2020 or until 60 days after the expiration of the Governor's disaster emergency declaration, whichever would come first. Therefore, municipalities are able to hire seasonal employees prior to completion of all background checks if the individual meets specific conditions stated in the act. This act also addresses provisions for individuals seeking recertification of their background checks. Finally, legislation is being introduced to address the provisional hiring limitations beyond December 31 and the current emergency declaration.

Additionally, Representative Jason Ortity and Senator John DiSanto circulated [cosponsor](#)

[memos](#) expressing intent to introduce legislation allowing local governments greater advertising flexibility to reach constituents in a more efficient and effective manner, including advertising on municipal websites. This is an important measure that will help local governments save money and reach a larger constituency. Please contact your Representative and Senator to ask for their support of this issue and to sign onto their respective cosponsor memo.


